Accident Waiver & Release of Liability

I know that riding a bicycle is a potentially hazardous activity and may require me to engage in strenuous physical activity. I further understand that serious accidents occasionally occur during bicycle riding, and participants in bicycle riding occasionally sustain mortal or serious physical injury. I should not enter this event unless I am medically able and properly trained. I also know that rider protection and safety is the primary concern to the organizers, but that traffic and road conditions are not totally within their control. In consideration for the acceptance of this registration for the MINDS IN MOTION BICYCLE TOUR, I hereby waive, release and discharge any and all claims for damages for death, personal injury, or property damage, which I may have, or which may hereafter accrue to me, as a result of my participation in said event. I freely assume all risks associated with my participation in said event, including, but not limited to, contact with other participants, falls, effects of weather, traffic and road conditions. "A participant in a recreational activity...accepts the risks inherent in the recreational activity of which the ordinary prudent person is or should be aware" (WI Stats. 895.525(3)(4)). This release is to discharge in advance the promoters, the sponsors, the tour officials and volunteers, and any involved municipalities or other public entities from or against any and all liability arising out of, or connected in any way, with my participation in said event, even though the liability may arise out of negligence or carelessness on the part of the persons or entities described above. I understand that as a bicycle rider I must obey all traffic regulations, and wear an approved helmet at all times while riding in this event. I further agree to abide by all the rules and regulations set forth in this event. It is further understood and agreed that this waiver release and assumptions of risk is to be binding on my heirs and assigns. I also give permission to use any photos taken during this event to be used for promotional purposes. By continuing the registration process, I acknowledge that I have read and understand the above accident waiver and accept the provisions contained herein.
